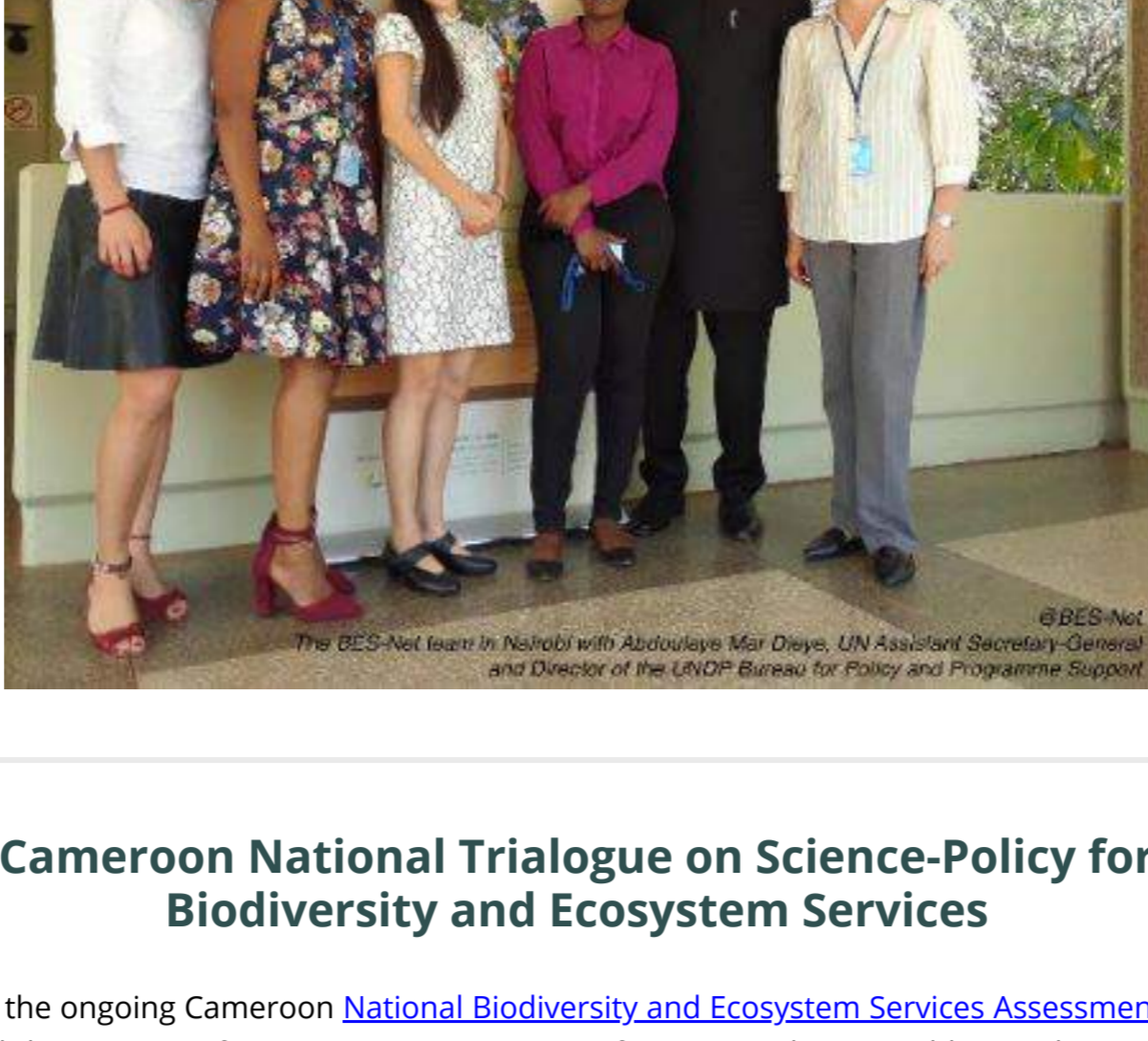

Dear Members of the Biodiversity and Ecosystem Services Network,

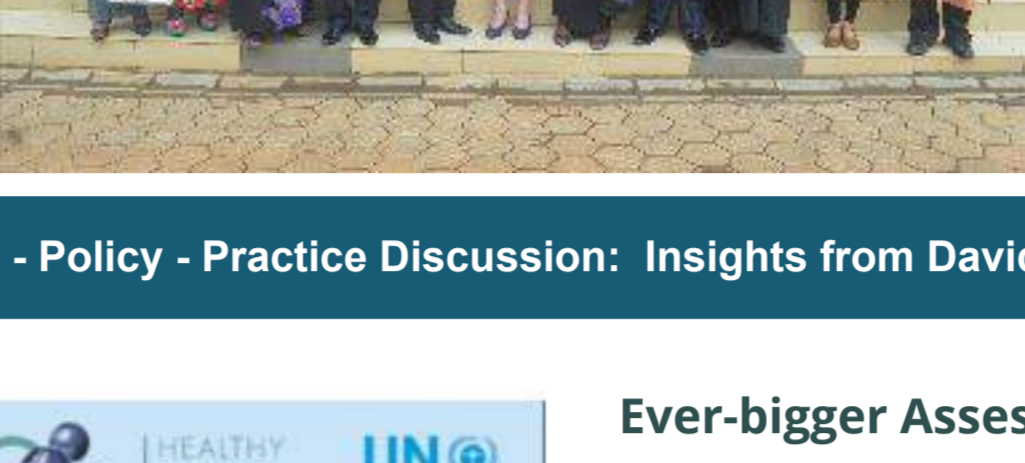

Cameroon National Triologue on Science-Policy for Biodiversity and Ecosystem Services

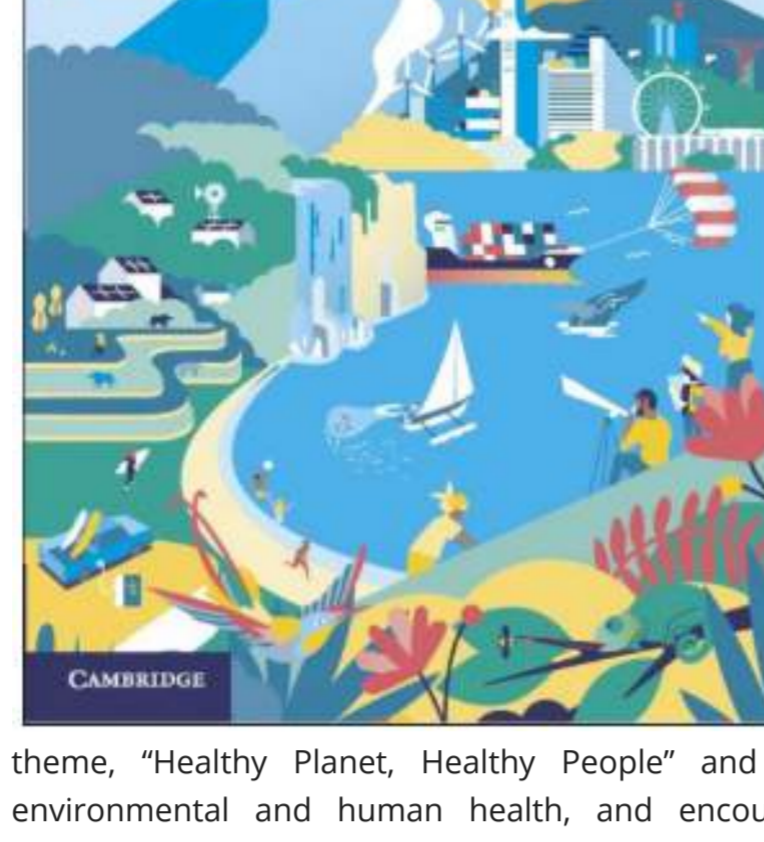
As part of the ongoing Cameroon National Biodiversity and Ecosystem Services Assessment, BES-Net supported the Ministry of Environment, Protection of Nature and Sustainable Development and the Network for Environment and Sustainable Development in Central Africa (NESDA-CA) in organizing a 3-day National Triologue in Yaoundé, from 25 to 27 February 2019, both technically and financially. On Day 1 and 2, the authors jointly reviewed the first order draft assessment to ensure synergy and consistency among chapters, identified information gaps and improve policy-relevance of the assessment questions and messages. Day 3 was organized in the format of an interactive science-policy dialogue between the authors' team and the National Platform for Science-Policy Interface on Biodiversity and Ecosystem Services to present the outputs from Day 1 and 2, and refine further the policy questions as per the latest government policy demands and priorities. The event not only contributed to fine-tune the focus and direction of the assessment but also helped enhance public awareness of the initiative with prominent media coverage. Ever-bigger Assessments

I sometimes wonder whether future generations will chart the progression of our environmental crisis simply by graphing the size/weight of the reports on it. It would certainly be quicker than reading them! The only GEO report which I have in hard copy (GEO-4) weighs in at just a tad under 2kg (paperback) and is "only" 500 pages.



Last month's United Nations Environment Assembly meeting saw the release of GEO-6, the Global Environment Outlook 6 report, available [here](#) as a whopping 745 page, 370 MB download. The GEO-6 Summary for Policy-Makers was agreed in January 2019 and is available, in all six UN languages, [here](#) as a 28 page 33.7 MB download.

The GEO-6 report is organized under the theme, "Healthy Planet, Healthy People" and draws attention to the connection between environmental and human health, and encourages the achievement of the environmental dimensions of the SDGs, internationally agreed environmental goals, and the objectives of multilateral environmental agreements (MEAs). For those too busy to even manage a 28 page read, GEO-6 Co-Chairs Joyeeta Gupta (India) and Paul Ekins (UK), with a number of co-authors, have distilled the assessment down to a 3-page commentary, available [here](#). And, finally, for those who cannot stay still for long enough to read 3 pages, [here](#) is a link to a 1-minute video message from Joyeeta Gupta.

No matter how you prefer to get it, the message from GEO-6 is clear – our abuse of the planet's health is rapidly becoming a case of self-harm – and the window of opportunity to reverse this is rapidly closing.

The fourth UN Environment Assembly (UNEA-4)

As global environment leaders gathered at the Fourth UN Environmental Assembly (UNEA-4) in Nairobi from 11-15 March, there was a great opportunity to put in place plans to reverse the loss of nature by 2030. Such an event was the Ministerial Roundtable on main outcomes of the 2018 UN Biodiversity Conference and the development of the post-2020 global biodiversity framework, called Advancing the Biodiversity Agenda. 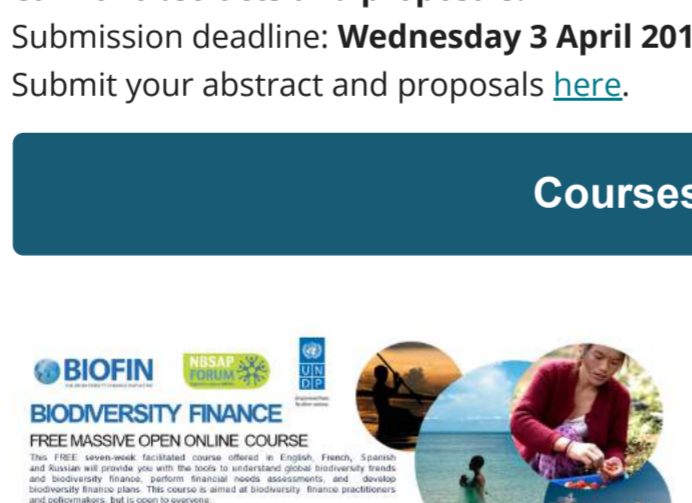
Oceania Ecosystem Services Forum (OESF) 2019

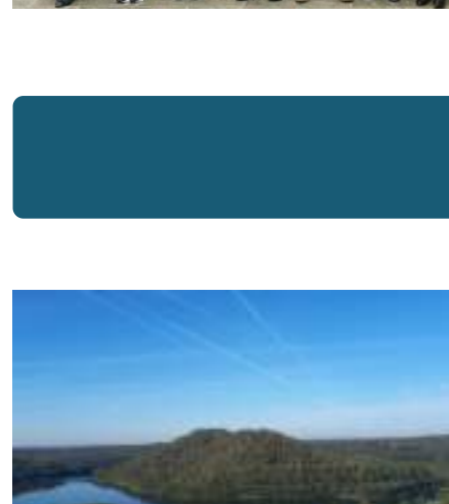
