

A Word from the BES-Net Team

Firstly, we would like to wish all of our partners and readers a very happy and prosperous new year! 2018 promises to be another exciting year with interesting developments in the area of biodiversity and ecosystems services on the horizon.

2017 marked a year of growth and expansion for BES-Net with network partners increased by 12 percent to 91 entities. BES-Net web portal users now comprise close to 650 registered users from all three target communities of policymakers, scientists/knowledge holders and practitioners. Thanks to the contributions from partners, web portal users and other stakeholders, over 700 new resources were added to the web portal library in different thematic areas.



BES-Net organized its very first regional <u>Trialogue</u>, a forum to foster multi-stakeholder dialogue and capacity-building across sectors and the communities of science, policy and practice, in Sarajevo, Bosnia and Herzegovina, in October 2017, with special focus on the Eastern European region. The <u>First Regional Trialogue on Pollinators, Food Security and Rural Development</u> brought together some 60 participants, encompassing about 40 stakeholders from Albania, Bosnia and Herzegovina, Georgia, Moldova and Montenegro with the objective to raise awareness about the relevance of the findings of the <u>IPBES thematic assessment of pollinators</u>, pollination and food production in Eastern

Europe. Key regionally and nationally-relevant risks and opportunities for pollinators and pollination were identified, and priority areas of collaboration and action agreed upon. These will be implemented over the next few years to protect pollinators, ensure sustained agricultural and food production. More details can be found in the Trialogue Action Document.

Furthermore, in close partnership with the <u>UN Environment World Conservation</u> <u>Monitoring Centre (WCMC)</u>, BES-Net is supporting four selected countries (Cameroon, Colombia, Ethiopia and Viet Nam), in developing capacities to conduct national assessments of biodiversity and ecosystem services. Looking ahead, this year, BES-Net will continue supporting the national biodiversity/ecosystem assessment efforts and organize further Trialogue events at regional and national levels in support of the IPBES thematic assessment process. In this context, we are looking forward to the launch of the summary for policymakers of the thematic assessment of land degradation and restoration at the upcoming <u>sixth</u> <u>session of the IPBES Plenary</u>. BES-Net will also make the web portal more accessible, relevant and user friendly based on the invaluable user feedback received to-date and expand its outreach to Francophone stakeholders by launching the French version of the website.

Science - Policy - Practice Discussions: Insights from David Duthie

Ecosystem services - 35 years old and still growing

2018 sees the concept of "ecosystem services" (ES) reach the prime age of 35 years, taking Paul Ehrlich and Hal Mooney' 1983 article "Extinction, substitution, and ecosystem services" Bioscience 33 (4), 248–254 as the seminal article introducing the term¹. The growth of the ES concept since then has been spectacular – with more published articles in 2016 alone (~3000) than in the entire period from 1983-2010 (2386, according to Costanza & Kubiszewski (2012).

This reflects the evolution of ES through its early conceptual framework phase, followed by a phase focused on assessment and valuation (e.g. MEA, TEEB, the UK National Ecosystem Assessment, and recent and ongoing IPBES assessments) with the last few years seeing ES struggling to become a fully operational component of sustainable development. This has entailed a further development of the original conceptual framework to include circular (or two-way) flows of services, embracing socio-ecological systems, multiple bundles of ES benefits and dis-benefits, trade-offs and landscape heterogeneity. The growing network of experts assembling under the IPBES "umbrella" has an important role to play to bring these complexities through from the research field to policy-makers and practitioners!

Training Course on Agroecological Crop Protection (ACP) organized by INRA, represents a new field of research and applications yet to be thoroughly studied and disseminated. In line with current objectives assigned to crop protection, ACP creates a breakthrough in cropping system design and in the management of interstitial spaces, switching from agrochemistry to agroecology. This <u>training Course</u> will propose practical recommendations to help implement the agroecological transition, for temperate as well as tropical agroecosystems.

Introduction to Resilience for Development

From 23rd of January to 13th of February 2018, Part 2 of the free, trilingual Massive Open Online (MOOC), entitled Course "Applying Resilience Thinking to National Biodiversity Development Plans", will be held on **NBSAP** Forum. This course is hosted by <u>UNDP</u>, in partnership with <u>SwedBio</u> at the <u>Stockholm Resilience Centre</u>, the <u>Secretariat of the Convention on Biological Diversity</u>, <u>Pronatura</u>, <u>ECOSUR</u>, <u>NBSAP Forum</u> and <u>The Nature Conservancy</u>. The course is cofunded by the United Nations Development Programme and the <u>Swedish International Development Cooperation Agency (Sida)</u> through SwedBio at Stockholm Resilience Centre.

<u>UN Environment-World Conservation Monitoring Centre (WCMC): WCMC and BES-Net are "Developing capacity for undertaking national ecosystem assessments in IPBES"</u>





An important collaborative global project between BES-Net and the Sub-Global Assessment (SGA) Network (Secretariat hosted by UN Environment-World Conservation Monitoring Centre) is supporting national ecosystem assessments in four pilot countries — Cameroon, Colombia, Ethiopia and Viet Nam. The project is funded by the Government of Germany, Federal Ministry for the

Environment, Nature Conservation, Building and Nuclear Safety, International Climate Initiative (IKI). Excellent progress has been made by the national teams following the launch <u>workshop</u> hosted in Kribi, Cameroon in June 2017. In Cameroon, a government-mandated National platform for Science Policy on Biodiversity and Ecosystem Services (SPBES) has been set up to facilitate implementation of the assessment.

BES-Net team and WCMC will provide the national expert leadership groups and other relevant stakeholders in the four countries with technical support to address these priority needs through the organization of national Trialogue, the design of webinar series and online forums to share lessons and experience, etc., for each country over the coming years. Colombia has recruited a National Project Coordinator and has held their first Authors Meeting. Ethiopia has held several national team meetings and set up the necessary administrative structures. Viet Nam has developed Terms of Reference for the various assessment personnel, as well as undertaking national workshops to raise awareness of the project with local stakeholders. We look forward to sharing the progress and experiences of the national teams further in 2018.

Bio-Bridge: Regional Bio-Bridge Initiative Round Tables held for Asia, Africa and Latin America and the Caribbean



In October and November of 2017, the Secretariat of the Convention on Biological Diversity (CBD) convened three regional Bio-Bridge Initiative (BBI) roundtables for <u>Asia-Pacific</u>, <u>Africa</u>, <u>Latin America and the Caribbean</u>. The aim was to promote the Initiative and facilitate the sharing experiences and lessons learned with respect to technical and scientific cooperation for biodiversity. The roundtables also sought at facilitating interaction between Parties requiring technical assistance and

organizations that could provide such assistance. The three events brought together 40, 42 and 43 participants and resource persons respectively.

During the discussions, participants identified their countries' priority needs which could be addressed through technical and scientific cooperation and technology transfer. These included: invasive alien species, protected area management and tourism, control of illegal wildlife trade, protection/recovery of threatened species, ecosystem restoration, biodiversity monitoring and assessment, biodiversity information management; access and benefit sharing, ecosystem valuation and accounting, climate change and biodiversity, agricultural biodiversity, and general cross-cutting support (including project proposal development, resource mobilization and support for NBSAPs and enabling policy frameworks).

They also discussed potential opportunities for collaboration with the Intergovernmental Platform on Biodiversity and Ecosystem Services (IPBES) and the Biodiversity and Ecosystem Services Network (BES-Net) (presentation available here) as well as other organisations.

Countries were encouraged to actively use Bio-Bridge tools and services (such as the helpdesk and the <u>Bio-Bridge platform</u>) to communicate their priority needs and access available opportunities. Relevant organizations, agencies and private sector entities were also invited to use the BBI platform to offer technical assistance to countries in need.

PANORAMA: Solutions for a Healthy Planet launches new thematic community "Agriculture and Biodiversity"



What links Indonesian oceanographers with Ethiopian beekeepers? And what do eco-restaurants in Ecuador have in common with aquaculture facilities in Madagascar? They are all part of PANORAMA's new thematic community on "Agriculture and Biodiversity". It responds to the growing

demand for agricultural practices that benefit biodiversity instead of contributing to its loss. The new community was launched on 16 November 2017 in a side event at UNFCCC COP23 in Bonn, highlighting the potential of practical solutions in tackling climate change and adapting to its impacts.

During the event at the COP23 a new thematic community on "Agriculture and Biodiversity" has been launched under coordination jointly by Rare and GIZ in the context of two IKI funded projects. The coordinators already presented the first 15 solutions on the portal.

The EKLIPSE project is inviting a wide range of experts from different disciplines as well as policymakers and practitioners for an international discussion of the current knowledge on the effects of electromagnetic radiation (EMR) on wildlife. The aim is to highlight the current state of the art in this field, to identify knowledge gaps related to the impacts on different taxonomic groups and ecosystems, and to discuss the technical aspects and methodologies used in current studies.



Blue Solutions is a global project that is being implemented jointly by GIZ, GRID-Arendal, IUCN and UNE.

One of the project's objective is to promote learning from successful experiences in the management and conservation of marine and coastal ecosystems. For this purpose, Blue Solutions has established the training course "Blue Practice and Planning". This format provides an introduction to the theory and practical starting points of coastal and marine spatial planning. As the relevance and demand for this topic are growing, Blue Solutions in cooperation with the MARISMA project has developed a short video clip that explains the process of Marine Spatial Planning (MSP). <u>SwedBio: SwedBio, UN Environment and UNDP organized a Peer-to-peer Learning Forum on human rights and biodiversity</u>







On the 17th of November 2017, UNEP-UN Environment Poverty-Environment Initiative, UN Environment Ecosystems Division, SwedBio/Stockholm Resilience Centre, Natural Justice and International Development Law Organization had organised a Peer-to-peer learning event in Nairobi. The discussion focused on "Tools and strategies for implementing a human rights-based approach to the environment with a focus on biodiversity".

This Peer-to-peer learning forum provided a unique opportunity to together craft

in a suite of strategic solutions, rather than assuming there is a single tool or strategy that fits all. It also served as a space

for exploring synergies to catalyze their impact on human rights, biodiversity and ecosystems and implementing Agenda 2030. Besides organizers around twenty staff from PEI, UN Environment and the United **Nations** Development Program (UNDP) Global Centre for Resilient Ecosystems and Desertification based in Nairobi participated. The methodology used was informed by the Multi-Actor Dialogue Seminar methodology developed by SwedBio and a broad network of colleagues based on experience gained over the past decade 2 as well as participatory methodologies used by the other organizing institutions.

Kleinhans Fellowship for Community Forestry Research (28th February 2018 – Latin America)

The Rainforest Alliance has a long history of working with forest communities that have established their own locally managed enterprises, providing them with training and technical assistance on sustainable forestry practices, value-added processing, business administration, market access and more. Fellowship: Young Climate Experts (1st March 2018 – Bonn, Germany)

The Alexander von Humboldt Foundation's fellowship programme allows future leaders to spend a year in Germany working on a research-based project of their own choice in the field of climate protection. Fellows are free to choose their own hosts. Submit an application if you come from a non-European transition or developing country and are active in any of the following areas: scientific, engineering-based, legal, economic, health-related or social aspects of climate change. Up to 20 fellowships will be granted, funded under the Federal Environment Ministry's International Climate Initiative.

Biodiversity Informatics for African Freshwater and Pollinator Biodiversity (9th March 2018- Africa)

The JRS Biodiversity Foundation is issuing a Request for Proposals (RFP) for multi-year projects focused upon biodiversity data, knowledge and information services related to freshwater biodiversity and pollinator biodiversity. The foundation will award about \$1,600,000 among qualifying proposals by July 2018[1].
